14 Curtis von Trapp. Commissioner Miller and Commissioner Heller were unable to attend, and have been excused
15 from tonight's meeting. City Staff present: Lynn Hyde, Associate Planner; Gina Estep, Director Community &
16 Economic Development.

18 Chair Fancher asked if there are any changes to tonight's Agenda, and if tonight's Agenda is approved. There
19 was consensus to approve tonight's agenda, and no changes were requested.

34 Ms. Hyde briefed the Commissioners on the introduction of Title 13 Water and Sewer Amendments to the North
35 Bend Municipal Code. There was discussion, including questions and answers, between the Commissioners, Ms.
36 Estep, and Ms. Hyde regarding the proposed amendments to Title 13.

38 Chair Fancher asked if any of the Commissioners had anything for the good of the order.

40 Commissioner Gildersleeve asked about the hotel in North Bend. Ms. Estep answered that the hotel will begin
41 the project again in the spring.

43 Chair Fancher, Commissioner Ryon, and Commissioner von Trapp said they will be unable to attend the February
44 23, 2017 meeting of the Planning Commission.

46 Chair Fancher asked Ms. Estep if there is anything she could share about the recent Council Retreat. Ms. Estep
47 briefed the Commissioners on the retreat.

49 Commissioner Ryon asked whether the city council does the visioning for the city, or if it was a Planning
50 Commission function. There was discussion of Commissioner Ryon's comment and question, and Ms. Estep
51 answered in detail.
