CALL TO ORDER

10 The meeting was called to order at 7:00 PM.

13 Planning Commissioners present: Gary Fancher (Chair), Elizabeth Gildersleeve, Jim Luckey, Mary Miller, Dick
14 Ryon, and Curtis von Trapp. Commissioner Heller was unable to attend, and has been excused from tonight's
15 meeting. City Staff Present: Jim Barborinas, from Urban Forestry Services, Inc., the city's Tree Consultant; and
16 Jamie Burrell, Senior Planner.

18 **AGENDA ITEM #2: Approval February 8, 2018 Planning Commission Meeting Minutes**

19 The Minutes for the February 8, 2018 Meeting were Approved.

20
21 **AGENDA ITEM #3: Public Comment on Non-Agenda Items**

22 Rob McFarland, 1036 Maloney Grove Ave. SE, North Bend, WA, spoke. Mr. McFarland said he had no
23 comments on any non-agenda item, but asked if he could comment on tonight's topic of Tree Retention
24 Amendments to North Bend Municipal Code (NBMC) Chapter 19.10, Clearing, Grading Filling and Drainage.
25 Chair Fancher asked if any of the Commissioners had an objection. No one so spoke.

27 Mr. McFarland made comment on the proposed tree retention amendments to NBMC 19.10. Mr. McFarland
28 requested of Senior Planner Jamie Burrell a word version of the proposed redline edits from NBMC 19.10, and
29 stated he would then add his edits in, section by section, and send back for the Planning Commission's
30 consideration.

32 Joe Eddings, 43438 SE North Bend Way, North Bend, WA, spoke on non-agenda items. Commissioner Ryon
33 asked Mr. Eddings what business he has. Mr. Eddings answered he has a car wash in Snoqualmie.

35 There was discussion between Jamie Burrell and the Commissioners concerning the NBMC table of permitted
36 uses, and where the proposed changes are in the process.

38 **AGENDA ITEM #4: Introduction: Tree Retention Amendments to North Bend Municipal Code**
39 **(NBMC) Chapter 19.10, Clearing, Grading Filling and Drainage**

40 Ms. Burrell briefed the Commissioners and guests on the proposed amendments to tree retention.

42 Jim Barborinas, the city's Tree Consultant, briefed the Commissioners and guests on the proposed tree retention
43 amendments, and projected a photo slide show while speaking.

45 There was discussion between the Commissioners, Mr. Barborinas, and Ms. Burrell, including questions and
46 answers, on the proposed tree retention amendments. The discussion included whether four inches should be
47 considered a significant tree. The discussion also included credits for existing trees of various sizes not removed
48 in a development. During discussion, the Commission went through the proposed amendments page by page,
49 where there were suggested edits made to the document. There was discussion of designations of heritage trees
50 and landmark trees.

4 Ms. Burrell reminded that at the next Planning Commission Meeting on March 8th, the Commission will be voting

5 on a new Chair and Vice Chair. Ms. Burrell also advised that five terms of Commission seats are expiring on
