2 **THIS AMENDMENT** is entered into by and between KING COUNTY FIRE
3 PROTECTION DISTRICT NO. 10, King County, Washington ("District 10"), KING
4 COUNTY FIRE DISTRICT 38, King County, Washington ("District 38"), the CITY OF
5 ISSAQUAH, Washington ("Issaquah"), the CITY OF NORTH BEND, Washington ("North
6 Bend"), and the CITY OF SAMMAMISH, Washington ("Washington"), all Washington
7 municipal corporations (collectively, the "Parties").

RECITALS

10 A. On January 1, 1999, Eastside Fire & Rescue was created by interlocal
11 agreement pursuant to Chapter 39.34 RCW.

12

13 B. In December 2007, the Parties amended and replaced the original
14 interlocal agreement, as amended, with the Eastside Fire & Rescue Interlocal
15 Agreement, which extended the operation of Eastside Fire & Rescue to December 31,
16 2014 ("2007 Interlocal Agreement").

18 C. In January 2014, the Parties amended and replaced the 2007 Interlocal
19 Agreement, as amended, with another Eastside Fire & Rescue Interlocal Agreement,
20 which extended the operation of Eastside Fire & Rescue to December 31, 2021
21 ("Interlocal Agreement").

23 D. In March 2017, the Parties desire to extend the operation of Eastside Fire
24 & Rescue from December 31, 2021 to December 31, 2026, an extension of five years,
25 and to replace successive seven year renewals with successive ten year renewals.

AMENDMENT

28 In consideration of the mutual covenants and conditions contained in the
29 Interlocal Agreement, the Parties agree to the following amendments:


31 1. **Amendment of Section 2, Term:** REPLACE IN ITS ENTIRITY WITH:
32 "This Agreement shall be effective on January 1, 2015, and shall terminate
33 on December 31, 2026. It shall be renewed automatically thereafter for
34 successive ten-year terms."

36 ENTIRITY WITH: "Any party may withdraw from the Joint Fire Department
37 at the end of the initial twelve-year term, or at the end of any successive
38 ten-year term, by filing with the other Parties a notice of withdrawal in
39 January of 2024 or in January of the eighth year of any succeeding term,
40 as applicable."

41 3. **Amendment of Exhibit A, 14, Phase In/Calculation Years: ADD THE**
42 **FOLLOWING AS THE LAST TWO SENTENCES: "Subsequent updates**
43 **to the formula shall occur before May 30th, of every second year,**
44 **beginning in 2022. Updates shall be recalculated utilizing the most**
45 **recently available yearly data for NORCOM dispatch incidents and King**
46 **County Assessed Valuations."**




