36 request from the Planning Commission was concerning when the medium density zoning district would be
37 presented to the Planning Commission, as this zoning category could be used to attain some higher density and
38 therefore affordable housing. Mr. Miller indicated that we would have the ordinance amendment for the medium
39 density housing prepared for action in January 2019.
