David Miller briefed the Commission on tonight's topic of affordable housing and introduced Andy McKay of the Dahlin Group, Inc. Mr. Miller said the Council was presented the first of these presentations, and received the full packet on the second. There are two hypothetical affordable housing projects the Commission will look at tonight. On the first project site, John Day Homes had commissioned and prepared for the city to look at re-use of the Senior Center site with building a new Senior Center with a multi-story building and retail on the first floor. The second project site is the Park & Ride facility on West North Bend Way across the street from the Pour House.

Mr. Miller described the efforts of the King County Affordable Task Force. Mr. Miller stated that tonight's meeting will be informational only, and no action will be taken.

Andy McKay, of the Dahlin Group, Inc., 10900 NE 8th St., Bellevue, WA, addressed the Planning Commission and gave a Power Point presentation on affordable housing and the two hypothetical housing projects. During the
