21 **AGENDA ITEM #3: Approval of minutes from May 21, 2025 meeting**

22 Correction noted by Commissioner Matlock regarding the spelling of his name on the minutes (Matlock, not
23 Mattlock). Motion by Commissioner Fitzgibbon, seconded by Commissioner White to approve the May 21, 2025
24 meeting minutes as amended. The motion passed unanimously.

26 **AGENDA ITEM #4: Introduction, Hearing and Recommendation – Water and Sewer Regulation
Amendments to Title 13 with regards to Accessory Dwelling Units**

27 Associate Planner Caitlin Hepworth provided a summary of the proposed amendments, as well as the purpose and
28 associated state requirements the amendments are based on.

29 Chair Thiel opened the public hearing at 6:43pm. No comment was provided. Chair Thiel closed the public hearing
30 at 6:43 pm.

31 Commissioners provided the following comments:

32 1. P. 2 of the amendments. Spell out Equivalent Residential Unit (ERU) in first use of it in the regulations.
33 2. Is there an opportunity to have separate dwellings at one address under the same bill? Staff can inquire
34 with Finance about that, but it wouldn't be a part of the regulations.
35 3. 13.08.010(A) – add "or" back in.

36 Motion by Commissioner Pereira, seconded by Commissioner Fitzgibbon, to recommend approval of the
37 amendments to the Water and Sewer Regulations in NBMC Title 13 as presented, subject to the additional revisions
38 requested at tonight's meeting. The motion passed unanimously.
